The Frederick Co VA book says she is the widow of James B. Smallwood. As you

know his name could have been spelled either Bidon or Boyden probably correctly spelled Boyden but corrupted to Biden or Bidon. Yes his father was definitely James and his middle name comes from Mary Boyden.

I can't find this Smallwood Thompson person yet. I suspect both he and Elisha were in Maryland. You need to go the the MD State Archives on Rowe Blvd in Annapolis to check their name file. I bet both show up with clues galore. I would love to but working everyday, finishing that book for Hopkins Press, and this often debilitating lupus seem to keep me away.

The Keith article is definitely wrong. It is also misleading on the original settler's wife. Will get into that later.

I do have a strong suspicion about Jemima's maiden name but don't yet have the primary source documents to prove it, only circumstantial evidence bolstered by some census evidence that is hard to refute. Hate to say anything is certain until I have it absolutely right.

I do have that rascal who questioned Jemima, Smallwood Thompson as one of the Appraisers for the estate of James Smallwood (son of John son of James son of Col James) in 1792 in Charles Co. MD. Interestingly, he was appraising with John Berry who I suspect was related to the 1769 Benjamin Berry that James Biden Smallwood sued. It gets interesting here.

Clues about Smallwood Thompson might be--

Henry Thompson son of Smallwood Thompson shows on the 1800 Charles County MD Census as a male 26-45 with a wife and 14 slaves

and

James Smallwood (son of James Smallwood son of Thomas Smallwood son of Col James Smallwood) marries an Eleanor in Charles County. Among their children is an Ann who married an unknown Thompson according to James will in Charles Co MD probated 1/12/94. I suspect this Ann had son Smallwood Thompson who had son Henry wtih the 14 slaves.

Clues about the John Berry might be--

William Smallwood (son of John son of William son of Col James) was on the 1776 census of Prince Georges County living in St. John and St. George Parish with a neighbor named John Berry.

The 10/24/78 will of Thomas Berry of Charles Co MD directs that William Smallwood son of John be allowed to have use of his upper plantation in Prince George's Co so long as he conducts himself properly as a tenant. Thomas Berry was probably related to both John and Benjamin Berry More of that intrigue!

Well, this is all that I have in the way of primary sources for this mystery so far.

Now, I really must go to work.
