Hello All,

Jan kindly sent me a copy of the will of BENJAMIN ROMAINE, which she located in the DAR library in Washington, D.C. The will is dated February 8, 1823 and was proved July 25, 1829. According to the DAR record, this is the BENJAMIN who was born in 1748. This information supports the lineage set forth in the Davis book, "Our Kinsmen" and is contrary to Ackerman's assertion (as I understand it) that it was the BENJAMIN born in 1746 who is the correct ancestor -- he lists no children for the 1748 BENJAMIN.

Jan also sent me a copy of the Inventory for RALPH BENJAMIN, the son of the 1748 BENJAMIN. RALPH BENJAMIN died intestate in 1860. Below are my transcriptions of the Will and the Inventory. It is my first attempt at transcibing 19th century writing so if those of you who have copies of the Will and Inventory find any errors (or can fill in the blanks), please let me know. I have tried to be as accurate as possible in transcribing them exactly as written, including spelling.

{Will of BENJAMIN ROMINE, dated February 8, 1823; proved July 25, 1829.}

In the name of God amen I BENJEMIN ROMINE of the ponds in the township of franklin in the County of Bergen and State of New Jersey farmer being at present in a good State of health and of a Sound Desposeing mind memory and Understanding. thanks be to god for the Same and as to my worldly and temporeal Estate where with it hath pleased god far above my deserts to bestow upon me do upon this Eight day of February in the year of Our Lord One thousand Eight Hundred and twenty three make publish this my last will and Testament in manner and form following that is to Say. I recommend my Soul to god who gave it and my Body to the Earth from whence it was taken. I appoint my friends Garit P. Hopper and Henry C. Hopper the Executors of this my last will and testament. it is my will that my Executors Shall after a reasonable time Sell my personal property and So much of my Real Estate to pay all my Just debts and funeral Expenses. I give and bequeath unto my Son RALPH B. ROMINE ten acres be the Same more or Less lying in the Platty Clove (?) to him and to his heirs forever. it is my will that my Son Ralph B. Romine Shall Enjoy the Remainder of my Real estate during his life time but he is not to make waste of the property. it is my will that the Sons of my Daughter RACHEL ROMINE late the wife of DAVID ROMINE = BENJEMIN ROMINE and NOCOLAS ROMINE the Sum of fifty dollars Each to be paid out of my personal property One Year after my Demise [?] fifty dollars | the remaining fifty dollars One Year after. it will that the Daughter of my grand Daughter TINEY Shall Share alike with my Sons Daughter. It is my will that after the death of my Son RALPH B. ROMINE my Executors Shall Sell my Real Estate and divide the Same among the Surviving Heirs of my son RALPH B. ROMINE the males to have two Shares and the females One Share/ It is my will that if any of my grand Children Shall die without having lawful Issue then that Share to be Equealy divided among the  ${\tt Surviv}$ =eing heirs | In witness whereof I have hereunto Set my hand and Seal the day and year first above written | Signed Sealed published and declared by the Said Benjamin Romine as his last will and testament in the presence of us and of Each Other.


