> Q1) Do you think the Thomas PRICE mentioned in the Russell Co,VA deed is the > same Thomas PRICE that married Minerva ROMINE?

At this point, I don't have enough on him to know for sure. The Romine family that he married into in Ohio appears to have come to Muskingum Co from Harrison Co, WV and were possibly from Loudoun Co or Frederick Co. Thomas Price and Minerva marry in 1838 or thereabouts. Thomas dies, leaving Minerva a widow and she remarries to Jesse Romine. So at this point, I would tend to think that the husband of Minerva, if he is related at all to the Thomas Price of KY which Linda wrote about, would have to be a son, making a late, second marriage or a grandson who dies relatively young. All of which is to say that I doubt that they are the same person...the fellow in the deed and the fellow in Ohio.

However, it may be a lead that the elder Thomas Price, who would appear to have lived somewhere in VA, may have lived in Russell Co. From the birthdates and places of the children sent by Linda, it looks like he was in KY by 1793 which is too early for him to be the fellow in the deed (mortgage) but it may be that he is the unknown son of Linda's list. One would have to get some tax records or census stuff to determine how many families of the name were in Russell Co in that time

Thanks for the great transcript of the deed, BTW.
