For those of us who are having trouble locating VA & WV records on our Romines, I found this interesting paragraph in the Foreward to this book: "...Many of the marriages in these 2 states (VA & WV) were never recorded, or the records were lost. All or a major portion of the public records of about 30 VA counties were lost due to fires before, during & after the Civil War. Those lost records included marriage bonds, marriage licenses & ministers' reports of marriages. Even tho marriages were suposed to be reported to county clerks, many of the ministers, especially itinerant clergymen, did not comply. In addition some of the marriages were not performed by ministers, such as those unions which were the result of the publication of banns in the various churches. Some unions were made by the "handfast ceremony," by which a couple would stand up at a public gathering, raise their clasped hands in the air & declare that, there being no minister available then, the man & woman intended to live together as man & wife for one year w/ the proviso that they would be legally joined together by a minister when one became available. The couple also had the option at the end of the year to separate without being married. Any child born of such a union was not considered illegitimate. There were also cases in the earlier days in VA & WV that couples ran away from home to the West & never were actually married, but spent the rest of their lives together as man & wife."
