Since I seem to be the "will lady" these days, I thought I would share the Will of my 3GGrandfather, Lambert S. Romain. Lambert is the son of Nicholas I. Romine (who's will I posted last week on the list). There is also a 4 page Inventory which I will post after I finish typing. Here is the will:

Will of Lambert S. Romain - #1312 P - Proved August 21, 1872 and recorded in Book

D (this could be a "G") of Wills for Passaic County on page 200

I Lambert S. Romain of the Township of Pompton in the County of Passaic and State of New Jersey, do publish and declare this to be my last Will and Testament in manner and form following:

Item first: I give devise and bequeath unto my Son Charles C. Romain all my lands and buildings lying on

the south side of the road leading from Pompton to the Ponds (in Bergen County) which said property lies in front of the House in which I now live to have and to hold the same forever when he arrives at the age of twenty one years –  $\frac{1}{2} \left( \frac{1}{2} \right) \left( \frac{1}{2}$ 

Item third: It is my Will and I do hereby give devise and bequeath unto my Son Lambert Romain all that part of my homestead farm and the buildings, on the north side of the land leading from Pompton to the Ponds in Bergen County (theres a big ink blot here) , the farm on which I now reside to have and to hold the same forever when he arrives at the age of twenty one years –  $\frac{1}{2} \int_{\mathbb{R}^n} \frac{1}{2} \int_{\mathbb{$ 

Item fourth: It is my Will and I do hereby order and direct my son Lambert Romain to pay my daughter Emeline Card or her heirs Two hundred and fifty dollars when he arrives at the age of twenty one years.

Item fifth: It is my Will and I do hereby order and direct my Sons Charles C. Romain and Lambert Romain to pay my daughters Elisabeth and Mary Francis each Five Hundred Dollars when said boys arrive at the age of twenty one years and said Daughters to have all my Household furniture when they arrive at twenty one years -

Item sixth: It is my Will and I do hereby give devise and bequeath unto my sons Charles C. and Lambert Romain all my woodlands to have and to hold the same forever when the youngest arrives at the age of twenty one years –  $\$ 

Lastly, I do hereby nominate constitute and appoint John Bertholf Executor and my Wife Sarah Catharine Romain Executrix in and to this my last Will and Testament and do hereby direct and order them to sell enough of my personal property to pay my just debts.

It is my Will and I do hereby give to my Wife Sarah Catharine the use of all my real and personal property until my sons arrive at the age of twenty one years but if she marries then her rights are to cease immediately.

Signed, sealed published and declared this to be my last Will and Testament this 29th July 1872
