Ηi,

Well, I am still poking around trying to learn more about who the children of Cornelius Romine might have been. To refresh your memories, Cornelius Romine married Hannah Smith on 1 Dec 1788. By the time Cornelius' father, John Romine wrote his will in 1807, Cornelius had died. On 4 April 1816, Hannah Romine requested a certificate of transfer from Hopewell MM to Stillwater MM. She was received by the Stillwater meeting later that year. What became of her and her nemeless children after that is unknown.

It was my thought that perhaps if I could identify Hannah's brothers and sisters, some one who was working on the Romines in Ohio might recognize some of the names as having occured with Romines there and perhaps proved us with some clues about what became of Hannah's children. So please check your notes, databanks, etc and see if we can shake anything out of the trees.

What follows is the little bit that I have currently found on Hannah's possible parents and her brothers and sisters.

John Smith and wife Ann and their children, Mary, Margaret, Hannah, Thomas, Ann, Susannah & Rebekah transferred to Hopewell MM from Warrington MM on 4 Jun 1770. (Is Warrington in PA?)
Children:

- 1. Mary--married a Cleavinger, probably Joseph, in about 1774.
- 2. Margaret--m. 12 April 1780 to Robert Haines
- 3. Hannah--m. Cornelius Romine as above
- 4. Thomas--m. Phoebe Sinkler 10 Oct 1787 in Loudoun Co, VA
- 5. Ann--m. a McKay about 1777
- 6. Susannah--m. about 1788. (Name of husband not given in Quaker records but may have been Angus Jennings.)
- 7. Rebecca--m. 11 Jan 1786 to Joshua Swayne

John, Hannah's father, probably lived in the area of Old Frederick Co which as a part of Greenway Manor. In 1800 the Thomas Brian Martin estate sold a number of lots in Greenway Manor to Richard Briarly. One of the lots was currently being resided upon by Joseph Clevinger and was said to be corner to John Romine & John Smith's lots. I do not know if this would be John Smith Sr. or Jr. as I have no dates for either John beside the marriage dates given above.

Of these folks, Thomas is the only one that I know of so far that did go to Ohio. In 1814 he and his family transfer their memberships to Short Creek MM.

Anyway, I hope that this will help.
